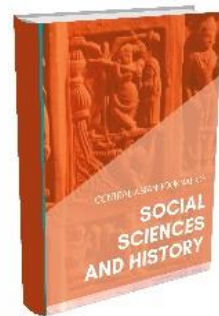

All the coalition formed a compromised arrangement initially for an agenda of development, but the working among these coalition governments had various short-coming. The entire working of all these coalition governments in the state is characterized by Consent and Conflictual state of affairs. The competitive nature of regional politics of Jammu and Kashmir finally resulted inestimable changes in the political affairs of the state. The coalition governance in the state had not been created such type of atmosphere which would facilitate declaration of all issues which are obstacles in the development of state. Later on after 2018 the political leadership lost their quality of good leadership in the Jammu and Kashmir state. Jammu and Kashmir is a part administered by India as a union territory until 5, August 2019; it was the name of a state administrated by Indian union. On 5, August 2019, The Jammu and Kashmir Reorganization Act 2019 proposes to bifurcate Jammu and Kashmir state into two union territories (UT's) Jammu Kashmir and Ladakh union territory. Ladakh was previously a part of the Jammu and Kashmir state and turn out to be a separate union territory on 31 October 2019. Similar to union territory of Puduchery, Indian administrated region of Jammu and Kashmir union territory have multi-party democratic system of governance having legislative Assembly. Jammu and Kashmir was the only Indian state that has its own state flag, however, the temporary and transitional Article 370, of the Indian constitution which, arranged Jammu and Kashmir self-rule, was scrapped in 5 august 2019, the state flag has lost its status. The scraping of special status of Jammu and Kashmir fully integrated into India.

CHALLENGES AND ISSUES OF GOOD GOVERNANCE

The state Jammu and Kashmir had in front of her diverse challenges to build good quality of governance put into practice across the state which has severe impact on the socio-economic development of the state.
